On January 18, 2022, the United States District Court for the District of Puerto Rico entered an order [Docket Entry

No. 17639] (the "Confirmation Order") confirming the Modified Eighth Amended Title III Joint Plan of Adjustment of the Commonwealth of Puerto Rico, et. al., dated January 14, 2022 [Docket Entry No. 19784] (as may be amended or modified, the "Plan"). The "Effective Date" of the Plan occurred on March 15, 2022.

Pursuant to the Plan, holders of savings notes issued by the Commonwealth of Puerto Rico pursuant to Act No. 7 of the Legislature of Puerto Rico (the "Notas") are entitled to a combination of New GO Bonds, GO CVIs and cash via a mandatory exchange. Upon distribution of the New GO Bonds, GO CVIs and cash, such existing Notas shall be cancelled.

Notice is hereby given to the holders of the Notas (issued in or prior to 2012) listed below that the distributions pursuant to the Plan related to such Notas are unpaid.

If you are a holder of Notas entitled to distributions pursuant to the Plan, to receive your distribution of securities and
