THIS NOTICE RELATES TO THE NOTAS DE AHORRO SAVINGS NOTES ISSUED BY THE COMMONWEALTH OF PUERTO RICO. YOU SHOULD READ THIS NOTICE CAREFULLY AND REVIEW THE LIST OF HOLDERS OF NOTAS.

THE DEADLINE TO RESPOND TO THIS NOTICE IS JULY 21, 2024.

ANY HOLDER OF NOTAS DE AHORRO WHO FAILS TO TIMELY RESPOND SHALL HAVE ITS ENTITLEMENT TO DISTRIBUTIONS ON ACCOUNT OF NOTAS DE AHORRO DISCHARGED AND SHALL BE FOREVER BARRED FROM ASSERTING ANY ENTITLEMENT ON ACCOUNT OF THE NOTAS DE AHORRO PURSUANT TO THE PLAN.

TO HOLDERS OF NOTAS DE AHORRO SAVINGS NOTES ISSUED BY THE COMMONWEALTH OF PUERTO RICO:

On January 18, 2022, the United States District Court for the District of Puerto Rico entered an order [Docket Entry No. 17639] (the “**Confirmation Order**”) confirming the *Modified Eighth Amended Title III Joint Plan of Adjustment of the Commonwealth of Puerto Rico, et. al.*, dated January 14, 2022 [Docket Entry No. 19784] (as may be amended or modified, the “**Plan**”).<sup>1</sup> The “Effective Date” of the Plan occurred on March 15, 2022.

Pursuant to the Plan, holders of savings notes issued by the Commonwealth of Puerto Rico pursuant to Act No. 7 of the Legislature of Puerto Rico (the “**Notas**”) are entitled to a combination of New GO Bonds, GO CVIs and cash via a mandatory exchange. Upon distribution of the New GO Bonds, GO CVIs and cash, such existing Notas shall be cancelled.

Notice is hereby given to the holders of the Notas (issued in or prior to 2012) listed below that the distributions pursuant to the Plan related to such Notas are unpaid.

If you are a holder of Notas entitled to distributions pursuant to the Plan, to receive your distribution of securities and cash, you must complete and submit the Notas distribution form (the “**Distribution Form**”) available on [https://cases.ra.kroll.com/](https://cases.ra.kroll.com/puertorico/) and provide proof of your Notas holdings to the Disbursing Agent, Kroll Issuer Services, US (formerly Prime Clerk LLC) (“**Kroll**”), on or before **July 21, 2024** (the “**Submission Deadline**”). The Distribution Form collects the information necessary to effectuate the distribution to holders of the Notas.

Any holder of Notas who does not submit a Distribution Form on or before the Submission Deadline (July 21, 2024) shall have its entitlement to distributions on account of the Notas pursuant to the Plan discharged and shall be forever barred from asserting any entitlement on account of the Notas pursuant to the Plan.
