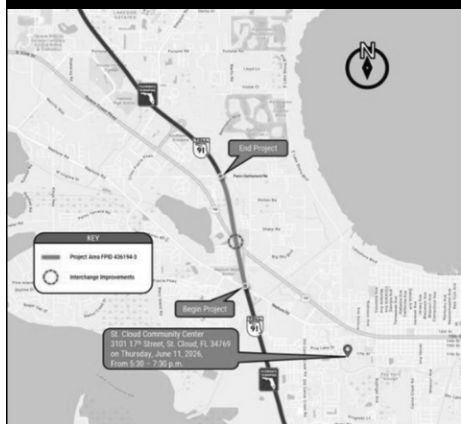
The proposed improvements include widening of a one and half-mile section of Florida's Turnpike Mainline/SR 91 from south of US 192 to Partin Settlement Road. This widening will increase the number of travel lanes from four to eight.
