MIAMI-DADE PUBLIC HOUSING AND COMMUNITY DEVELOPMENT ONLINE WAITING LIST PRE-REGISTRATION FOR THE PUBLIC HOUSING PROGRAM OCTOBER 2024

Miami-Dade Public Housing and Community Development (PHCD) will accept online applications from October 15-25, 2024, for eligible low-income individuals, families, the elderly and persons with disabilities.

The public housing waiting list is open only to residents of Miami-Dade County at the time of application, and residency will be verified with supporting documentation at the time of eligibility.

Please note that this new waiting list is not for the Section 8 Housing Choice Voucher Program.

Persons with disabilities may seek guidance with completing the application by contacting the Applicant Leasing Center at (786) 469-4300, between 8:00 a.m. and 5::00 p.m., Monday through Friday, except holidays.

All applications will go through a computerized lottery process and will be assigned a randomly selected ranking number.

The head of household must have a Social Security number to register online; however, applicants without a Social Security number will not be prohibited from applying. If you have any questions, please contact ALC at 786-469-4300.

Only one application per household permitted. Applicants will receive a receipt number as confirmation of the online submission. Any pre-application that is not fully and accurately completed will be disqualified. You will receive written notification with a confirmation of your application.
